Your email was forwarded to me, in my capacity as the Director of Communications for the office. The Littke case is in the Third Circuit Court for Wayne County Michigan. If you place Third Circuit Court for

Wayne County Michigan it will take you to a criminal case, look up where you can easily find Mr. Littke's case.

Here is what the Court's Register of Action looks like for his case. As you will see below, it was bound over in June and the final conference is scheduled for 8/8/25 before Judge Knapp. A trial is scheduled for 9/15/25.
